

## MEMORANDUM OF UNDERSTANDING

This Deed of Agreement is made on 6<sup>th</sup> October 2021 between the Principal, K.K.T.M Government College, Pullut, Kodungallur, Thrissur (hereinafter referred to as First Party and Chairperson, Kodungallur Municipality as 'second party

Whereas the first party has agreed to give away biodegradable waste generated and collected in the waste baskets supplied by the second party which have been agreed upon by both parties mutually as follows

The first party shall identify the quantum of biodegradable waste for disposal to the second party in fuller consent.

The details laid out in this MOU, notwithstanding the essence and spirit is an understanding between the first party and second party

Any notice or communication on this agreement shall be delivered personally by both parties each other or by way of E-mail which is set out in this contract as either party may specify by notice in writing to the other.

A confirmation by both the parties that no benefit either in cash or kind to any officer/employee/relative /associate of either party as reward or consideration either for entering in this MOU or other matter related to this agreement

Neither party shall be liable for damages for any delay or failure to perform its obligations here under if such delay or failure is due to reasons beyond the control of the concerned party without limitations, strikes, epidemics, etc

Any dispute arising out of this agreement shall be settled amicably between the parties. This MOU is subject to the jurisdiction of the courts of Thrissur (Dt).

The first party has the right to check and investigate the transporter of waste being collected from the college/vehicle carrying the waste.


The parties are covenant that they will comply with all applicable laws and regulations in their conduct pursuant to this MOU.

Both parties shall agree that it will not make use of, disseminate or in any way disclose any confidential information to any person, firm or business in this regard. Furthermore, the existence of any discussions, negotiations or agreements in progress between the first and second parties shall not be released to any form of public media without written approval of both the parties.

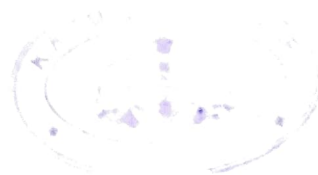




